Notice is also given that earnings calls with the market regarding the presentation of the consolidated periodic results will be held indicatively on the same day on which the Board of Directors meeting is called to approve such results, or, at the latest, on the trading day immediately following such approval. Day, time, and manner of holding will be announced from time to time.

In compliance with the provisions of article 82-*ter* of the Issuers' Regulation, approved by CONSOB resolution n° 11971 of 14th May 1999, it is hereby announced that the Board of Directors of BFF, which met today, resolved to prepare and disclose to the public on a voluntary basis – as additional interim information for the financial year 2023 in addition to the annual and half-yearly financial reports (mandatorily prepared and published pursuant to article 154-*ter* of the "*Testo Unico della Finanza*") – the consolidated balance sheet and income statement accounts as of 31st December 2022, as of 31st March, 30th June and 30th September 2023, which BFF is already mandatory to prepare for the purposes of reporting pursuant to the Bank of Italy's Circular n° 262 of 22nd December 2005 and as subsequently amended, in addition to the capital ratios and the key performance indicators commonly used in the financial sector.

The publication of this information is intended to ensure continuity with the type of financial information disclosed to the market at the time of the annual and half-yearly figures. This choice would also be consistent with that communicated by other listed banks, and in line with the *Policy for managing dialogue with all Shareholders and Bondholders* approved by the Bank's Board of Directors on 28th September 2021.

The aforementioned information, and the related documentation, will be approved by the Board of Directors on the dates indicated in the above Financial Calendar, and made available to the public through the publication of specific press releases on the authorised SDIR system <u>1Info</u>, and in the <u>Investors > Results</u> section of BFF Group's website.
